

As per Railway Board instructions in letter No. PC-VI/2015/IC/I dt. 05/04/2016 (RBE No.33/2016) the pay of Sri. Umesh Kumar Verma, ASTE/CN/BNC is revised duly extending the benefit of fixation of pay on promotion under Fule 13 of RBE No.103/2008 dt. 04/09/2008 (i.e. one increment equal to 3% of the sum of pay in the pay band and the existing grade pay is computed as rounded off to the next multiple of R.10 from the date of promotion and consequential increments are revised as under :-
